# 1. Organization of Research

**1.1 Domains:** This second phase of the InterPARES project has been divided into three domains of inquiry, each addressing a specific set of research questions: (1) the **first domain** will investigate the nature of the records under examination and the process of their creation; (2) the **second domain** will study the concepts of reliability, accuracy and authenticity, as they are understood in the various disciplinary areas involved in the research; (3) the **third domain** will test existing appraisal and preservation methods on the records in question and develop and test new ones. The grouping of researchers into **Domain Task Forces** promotes interdisciplinary collaboration where issues of concern are common to different types of activities.

**1.2 Focuses:** As shown by the organizational matrix (see last page), each domain comprises **three focuses**, each addressing a type of records: (1) the records of **artistic activities**, (2) of **scientific activities**, and (3) of **e**-**governmental activities**. The simultaneous grouping of researchers into Focus Task Forces allows for conducting case studies of records creators in the context of each type of activity, analyzing their records from creation to their ultimate appraisal and preservation by archival institutions or programs.

**1.3 Cross-domain:** Three cross-domain research units have been established, each addressing a key objective common to all domains: (1) the **Terminology Research Team** will control the use of terms and related definitions in all areas of the research, thereby ensuring consistency among the various research units while keeping into account disciplinary and cultural differences; (2) the **Policy Research Team** will analyze the existing policies and strategies in each domain and focus of inquiry, and distill from the findings and products of the task forces policies, strategies and guidelines for the reliable and accurate creation and maintenance of the records under examination, and for their authentic preservation within the context of each activity and culture generating them; (3) the **Description Research Team** will develop guidelines for the intellectual control and archival description of all types of records studied.

**1.4 Working Groups:** The organizational matrix (see last page) is constituted of three domains represented vertically and three focuses represented horizontally, for a total of nine areas. Working groups have been formed within each area, constituted of investigators with diversity of expertise.

**1.5 Roles of research units: (1)** the **primary role of Focus Task Forces** is to gather and analyze case studies and other data of relevance to each type of activity across multiple domains of inquiry; **(2)** the **primary role of Domain Task Forces and Cross-domain Research Teams** is to correlate these findings across focuses and formally address the project's research questions from an interdisciplinary and multicultural perspective; **(3)** the **primary role of the Working Groups** is to ensure that in the context of the activity of each focus the research questions of each domain will be adequately addressed, as well as to provide input through their chairs to the decisional process that is carried out at the **International Team** workshops.

# 2. Research Activities and Deliverables

During the first thirty months of the project, the primary research activities will be conducted by the Focus Task Forces, while the domain and cross-domain research units will do background research in preparation for the study of the data gathered by the focuses.

# 3. Team integration and cross-fertilization

The inherently collaborative research structure represented by the organizational matrix ensures that researchers with diverse expertise work together throughout the project. The face-to-face tangible collaboration among researchers and research units will occur at **weeklong semi-annual international workshops** in February and September. Between these workshops, research units will interact through the project on-line forum and through ad hoc face-to-face meetings. The value of having all of the researchers together for weeklong workshops cannot be overstated. From experience, we know that frequent international workshops supported by on-line researchers' forum are effective tools to ensure the integration of team members and research activities. The International Team (the chairs of all research unites and of the national and multinational teams, plus the project director), which has the function of

steering all research activities, will meet for three-day workshops in June and December. Advisory Board members are expected to attend one International Team workshop per year.

# 4. Project Web site

The planned project website will be managed and hosted by the InterPARES project administration staff. There will be three components to the website: (1) the public site, (2) the secured website and (3) the administrative website. The public site will contain a summary of the project, its goals, methodologies, organization, participants, events, documents, contact information, as well as resources and links. The secured site is available only to InterPARES researchers and will be divided into two parts: a resources section and a discussion and documents forum. The resources section will include a calendar of research activities, deadlines, project publications and events, detailed contact information of researchers, workshop photographs and copies of internal reports. The discussion and documents forum enable the researchers are able to communicate within research units when they are not meeting face-to-face. The administrative site will be available only to InterPARES administrative staff. It will allow for the automatic update of specific information in the resources section of the secure website from databases in the InterPARES office.

# 5. Stakeholders

Our approach regarding the various stakeholders in our research has been very inclusive; our group of investigators extends far beyond the academic realm, and features a substantial representation of archival institutions from around the world as well as business and industry. Thus, those institutions and communities with the most at stake in the outcomes of our research have been included as full participants. Even so, we will endeavor to present our research to as wide a range of communities as possible, and solicit public comment on our interim reports and preliminary findings through the website.

# 6. Dissemination

We expect that preliminary results and progress reports will be delivered at the annual conferences of the International Council on Archives, the Association of Canadian Archivists, the Society of American Archivists, as well as academic/scholarly and professional conferences devoted to artistic, scientific and technological research, especially interdisciplinary and international ones. Several peer-reviewed articles will be published by the researchers in the professional and scholarly journals of their respective disciplines, and in refereed proceedings of international disciplinary and inter-disciplinary and multi-disciplinary conferences. Given the length and complexity of the project, we do not expect to have many findings, methodological or theoretical, worth publishing in peer-reviewed venues before the fifth year of the project. Therefore, we cannot promise to publish more than 6-8 articles in the first 30 months of the project. Several findings will be best disseminated by means other than articles in peer-reviewed journals, such as electronic choreographies and other performances, art exhibitions, and prototype specifications. # 7. Student training

Student research assistants are hired and assigned to researchers on a *pro-term* basis. Nineteen research assistants each year will be involved in a wide variety of tasks. In the first half of the project, research assistants will work on case studies, conduct surveys and prepare annotated bibliographies, assist in the development and testing of models, and assist in the analysis of case study data. Most research assistants are master's students in their second year of study. This means that we can provide the names of the 19 students hired in the first year; however, we cannot do the same for the following years at this stage.

One postdoctoral fellow, Jean-François Blanchette, will work full-time on the project for its duration; the responsibilities of the postdoctoral fellow include developing and conducting some case studies, participating fully in the analysis of all case study data and development of prototypes, presenting findings at national and international projects, assisting in the training and supervision of research assistants.

# 8. Management Structure

(a) **Project Director** — The Director is responsible for the intellectual and administrative direction of the InterPARES 2 Project research, for chairing the International Team, chairing the Terminology Cross-domain Research Team, coordinating intellectual activities and ensuring consistency throughout the research. In addition, she is responsible for the following tasks: (a) the formal acceptance of new researchers; (b) the exercise of

disciplinary actions, when necessary; (c) the selection of the Advisory Board members and the communication to them of the research progress; (d) the supervision of the Project Coordinator and the Post Doctoral Fellow.

(b) International Team — Members: Project Director, and the chairs of all working groups, cross-domain research teams and national and multinational teams. Ex-officio non-voting members are the Project Coordinator, the Technical Coordinator and the Postdoctoral Fellow. **Purpose:** (a) approves the Organizational policy and monitors its implementation; (b) monitors the progress of the research, future project plans, associated milestones and deliverables for the research work of the InterPARES 2 Project; (c) decides on any change to the original research description and subsequent work plan; (d) arbitrates on any conflict within the project or negotiates a solution to such conflicts; (e) reports on the research activities and findings of research units or national/multinational team, reviews, discusses and reconciles them with the work presented by other members; (f) decides on dissemination activities; (g) assigns tasks and responsibilities to research units.
