# Web 2.0 – Social Media

#### Web 2.0

- Interactive service platform that supports interoperability, collaboration and information sharing
  - Web applications
  - Web-based communities
  - Wikis, blogs, social networking sites, virtual worlds, etc.

#### Social Media

 Applications designed to facilitate collaboration, creation and exchange of user-generated content

- Paradox information is both ephemeral and persistent

# Research Objectives

- Identify and evaluate consequences of the use of Web 2.0/social media on archival and records management theory and practice
- Explore whether use of Web 2.0 technologies is resulting in records creation
- Assess potential impact of the use of Web 2.0 technologies on the ability of archivists and records managers to manage potential records and preserve records

# **Research Questions**

- How are organizations using Web 2.0 technologies to conduct business?
- Do the products of this use have the characteristics of records? Are they being treated as records?
- Can existing theory and methodology adequately address any potential changes resulting from the use of Web 2.0 in generating records?
