

An Investigation into Long-Term Preservation and Copyright Compliance



#### **Research Problem**

Institutional Repositories (IRs) are being developed by universities internationally to create open access to the scholarly output of academic communities and preserve it long-term.

IRs collect materials ranging from published and unpublished works to scientific data sets. However, the literature shows that IRs lag behind on policies and procedures for long-term preservation and licensing of their content.

Established policies and procedures for the authenticity, security and accessibility of IR materials are essential to ensure continued access and preservation.

### **Research Objectives** and Questions

Identify and address the challenges presented to IRs by long-term preservation of the different types of digital materials they collect. **Research Ouestions:** 

- How to ensure the long-term preservation of and access to authentic materials, many of which are unique?
- How to ensure that no infringement of copyright legislation occurs during the processes of long-term preservation and access?

# **Research Methodology**

Action research with an ethnographic approach is being used in conducting the case study. Action research involves progressive problem solving that employs participative and iterative methods. It makes extensive use of case study methodology, as well as working jointly with subjects who act as both participants and contributors in the research activity.



## Collaboration

clRcle, the University of British Columbia's (UBC's) IR, began in 2007, and now contains about 25,000 items. Mandate: to collect research and teaching materials created by the UBC community and its partners, make them openly accessible and preserve them long-term. http://www.circle.ubc.ca

- A model preservation plan based on the case study plan
- A white paper on the necessary changes to copyright legislation
